

Good News for CLUBS ON PUBLIC WATERWAYS & WATER SKI LAKE OWNERS!!

The **USA Water Ski Insurance Team** has come through again! As the endorsed insurance agency for USA Water Ski, **Global Marine Insurance Agency** is pleased to announce that we now have a **General Liability** policy for *Clubs on Public Waterways* and Ski Lake Owners. Most of you are aware of the inability to obtain this type of insurance and now we have a great alternative.

The new policy was developed specifically for USA Water Ski and their members, clubs and lake owners. It is underwritten by Mt. Hawley/RLI Marine Insurance and is sold and service by Global Marine Insurance Agency.


The policy is issued in the name of USA Water Ski with each Lake or Club listed as a named insured. A certificate of insurance from the Master Policy will be provided to each of the Lakes/Clubs as proof of insurance. The policy is written with a \$1,000,000 per occurrence/per location aggregate limit with an overall policy aggregate limit of \$10,000,000. All lake owners/clubs must be USA Water Ski members in good standing and everyone who regularly uses the lake must also be members of the organization. The rates are competitive and the terms and conditions are very reasonable. The minimum premium for any risk is \$3,500 which includes a \$2,500 deductible. There are additional premiums that apply for activities such as ski jumps, the number of non-sanctioned events, location and the length of the season. This product is written on a Surplus Lines basis and therefore a policy fee of \$35 and state mandated taxes will apply. Each final quote will be customized to the lakes individual characteristics and needs. Once the coverage has been bound there will be a minimum earned premium of 25%.

If the lake is owned by a Homeowners Association, we must provide a copy of the current policy covering the Association's common areas to be considered for the Public & Private Lake Liability program.
